Community Hospital Opens Doors of New Hospital

After 51 years of operation at its original location at North 12th Street, Community Hospital celebrated the opening of their new facility located at 2351 G Road on Thursday, March 17th. Staff and patients moved to the new building the same day, and a ribbon-cutting ceremony was held the following morning.

The new four-story hospital, designed in a way that will easily accommodate future growth, offers 44 private rooms in over 140,000 square feet of space. The new emergency department, which can accommodate a 50% increase in visits from before, will be upgraded from a Level 4 to a Level 3 trauma center, allowing the hospital the ability to handle more serious cases. The adjacent radiology department makes it possible to expedite diagnoses of injuries and ailments.

Along with an intensive care unit, in-patient pharmacy, laboratory, and pathology department, the hospital houses a new childbirth unit with eight private suites to provide labor and delivery services and postpartum care. The unit also houses an operating room which is equipped to handle cesarean section deliveries.

This is the first time in 15 years that Community Hospital has been able to offer labor and delivery services, and the first baby born in the new childbirth facility arrived on opening day! "This is such an exciting day for Community Hospital" said Tonya Chapin, Director of the Birth Place at Community Hospital. "Our CEO announced the opening of our new hospital at 6:00 am and by 10:30 am our first two moms-to-be had already walked through the door."

We could not be more excited that this project has finally come to fruition," said Chris Thomas, President and CEO for Community Hospital.
